(This amendment eliminates language that prohibits the Department of Conservation and Recreation from procuring or accepting new lands for use as a State Park or Natural Area Preserve without a specific appropriation for such purpose. A series of companion amendments are included in the Capital Outlay section of the Appropriation Act.)

#### Language

Page 326, following line 49, insert:

"H. In order to establish a state battlefield park and recreational area in Culpeper County, the Department of Conservation and Recreation is authorized to acquire, by deed of gift or other means which do not require general funds or capital outlay, 1,205 acres of real property at Brandy Station and Cedar Mountain battlefields. Such property may be acquired from nonprofit historic preservation and land conservation organizations. Permitted activities at the battlefield park and recreational area may include heritage tourism, natural area activities, primitive camping, fishing, bow hunting, boating, equestrian activities, biking, and historical and military education. It is the intention of the General Assembly that this battlefield park and recreational area, after its establishment, shall require minimal improvements other than those necessary for the permitted activities. All permitted activities shall be consistent with the preservation and protection of existing historic, cultural, archeological, and natural resources."

#### **Explanation**

(This amendment would establish a state battlefield park at Brandy Station. The amendment would create the park upon transfer of the land, at no cost, to the Commonwealth by the relevant property owners. The intent of the amendment is to be revenue neutral.)

Second year grants shall not be awarded until after July 1, 2019."

(This amendment would increase the second year funding for the Virginia Land Conservation Foundation to the amount called for in HB 1398 of the 2013 General Assembly and include language requiring the VLCF to conduct a grant competition for the entire \$16.0 million prior to December 31, 2018. This will give the General Assembly the opportunity to see the proposed projects and how they ranked prior to the money actually being granted.)

As part of this assessment, the Department shall evaluate what amendments to the current Master Plan may be required as well as provide estimates of all associated capital and operating costs and timelines for completion. The Department shall provide this information to the Board of Conservation and Recreation no later than November 15, 2018."

(This amendment provides \$50,000 GF in the first year for development of a plan to expand bike facilities at First Landing State Park.)

It is the intent of the General Assembly that this funding shall be used solely for construction of bathroom facilities that are complaint with the Americans with Disabilities Act Standards."

## **Explanation**

(This amendment restores the full funding originally appropriated for the Swift Creek Ride Center at Pocahontas State Park. The remaining \$235,000 GF will be used to construct ADA complaint restroom facilities at the entrance of the trail, as the first seven miles of the ride center are constructed for hand-cycle accessibility.)

This parcel is owned by the Robert &Dees Leggett Foundation and contains the Blue Ridge Center for Environmental Stewardship (BRCES), which has roads, buildings, and infrastructure needed for park operation.)
